STUDENT REPRESENTATIVES: Ms. Ruopp updated the Board on winter activities, cross town challenge with Gilbert, Mr. Northwestern event delayed until March, National Honor Society talent show for Water for Sudan fundraiser, SHAPE meeting, student Senate Red Army, basketball game with Gilbert, and mid-term schedule.

Mr. Austin provided updates pertaining to: athletics, Mr. Williams remarkable win schedule, senate meeting with Prevention Coalition group, Second Chance club activity, school web site information, Students Helping Students group, mid-term exam study group, and pep rally update. Questions followed regarding "snap-chat" and discussion followed. Coalition Prevention group discussion followed, with Mr. Amara and Mr. Chichester providing information on the Coalition along with student involvement.
