# FIRST INFORMAL TOWN PRESENTATION - NORFOLK and BOARD OF EDUCATION MINUTES BOTELLE SCHOOL CAFETERIA

MARCH 11, 2020 – 7 p.m.

Ms. Sexton Read began the First Informal Town Presentation, Norfolk, of the Regional School District No. 7's Proposed 2020-2021 Budget Presentation, at 7 p.m.

Ms. Sexton Read's Power Point presentation began with highlighting historical expenditure increases, and continued with student PSAT results, testing result rankings within the Berkshire League, AP student scores, and CSDE Next Generation Accountability indicators. Budget drivers, particularly related to Special Education costs and outplacements accounting for 1.94 percent of the overall increase, along with an outline of efficiency measures, retirements and resignations were presented demonstrating Regional School District No. 7's continued ability of providing a high performing school district that meets the educational, social/emotional, and extracurricular needs of all students at an average cost and overall conservative and responsible increase. Further, Ms. Sexton Read provided an overview Object breakdown of Salaries, Benefits, Professional/Technical Services, Property Services, Other Purchased Services, Supplies, Property, Other Objects, Other Funds, Excess Cost Expenditure Offsets, Revenues and change in Average Daily Membership by Towns for a 2020-2021 Proposed Budget increase of \$624,367, or 2.90%. Regular Education Program expenditures account for 0.96, and Special Education expenditures account for 1.94 percent of the total 2.90% increase. Ms. Sexton Read concluded that Regional School District No. 7 continues to provide a rigorous and comprehensive educational program connecting students with their school and passions, an outstanding facility at costs in line with statewide average and per pupil expenditures in the lower half of the Berkshire League, thanking community members and expressing her appreciation for their support on behalf of all students within the District.

**PUBLIC**: Questions were addressed by Ms. Sexton Read, Dr. Palmer, Mr. Gaskins, and Mr. Amara from community members pertaining to: reduced enrollment and staff requirements, achievement and A/P opportunities, teacher negotiations, Middle School Math testing results, regionalization, and public relations. Requests were made for copies of the Budget Presentation to be made available at Town Halls. Discussion followed, and both Ms. Sexton Read and Dr. Palmer thanked community members for their attendance and support.

# **NEW BUSINESS**

Mr. Gaskins reviewed the requirement of annual Healthy Food Certification and following a brief discussion, and requested the Board make the ensuing MOTIONS.

MOTION by Mr. Nadeau, seconded by Ms. Bell, to ACCEPT LANGUAGE FOR HEALTHY FOOD OPTION as follows: Pursuant to C.G.S. Section 10-215f, the board of education or governing authority certifies that all food items offered for sale to students in the schools under its jurisdiction, and not exempted from the Connecticut Nutrition Standards published by the Connecticut State Department of Education, will comply with the Connecticut Nutrition Standards during the period of July 1, 2020, through June 30, 2021. This certification shall include all food offered for sale to students separately from reimbursable meals at all times and from all sources, including but not limited to school stores, vending machines, school cafeterias, culinary programs, and any fundraising activities on school premises sponsored by the school or non-school organizations and groups. **MOTION** by Ms. Kenneson, seconded by Mr. Gauthier, to **ACCEPT LANGUAGE FOR COMBINED FOOD AND BEVERAGE EXECMPTIONS** as **follows:** : The Board of Education or governing authority will allow the sale to students of food items that

do not meet the Connecticut Nutrition Standards and beverages not listed in Section 10-221q of the Connecticut General Statutes provided that the following conditions are met: 1) the sale is in connection with an event occurring after the end of the regular school day or on the weekend; 2) the sale is at the location of the event; and 3) the food and beverage items are not sold from a vending machine or school store. An "event" is an occurrence that involves more than just a regularly scheduled practice, meeting, or extracurricular activity. For example, soccer games, school plays, and interscholastic debates are events but soccer practices, play rehearsals, and debate team meetings are not. The "regular school day" is the period from midnight before to 30 minutes after the end of the official school day. "Location" means where the event is being held.
