Additionally, Dr. Palmer advised of 2019 graduation date of Monday, June 17, 2019, at 7 p.m. at the Warner Theater with Project Graduation immediately following at the Granby YMCA.

### Updates:

Ms. Sexton Read updated Board members of the productive Budget Workshop on Saturday, March 16, 2019, with the New Hartford Board of Finance providing highlights regarding: potential TRB assessments, reallocation in line items, line item budget balances, positive budget variance protection, and cyber protection concerns. Ms. Sexton Read advised that she will be adjusting the upcoming Proposed Budget Town Presentations pertaining to the reallocation in line items and positive budget variance in an effort to provide further clarification for town officials and community members. Brief discussion followed.

### **Budget Deliberations:**

Board members provided input from town officials and community members with a discussion including possible budget reductions, upcoming teacher negotiations, responsiveness to elected officials following the Special Meeting on March 6, 2019, and their responsibility to Regional School District No. 7 students. Mr. Gaskins shared that following the 0.93 percent budget increase for the 2018-2019 school year, the proposed 1.77 percent increase for 2019-2020 is a very responsible and honest presentation without jeopardizing the integrity of school programs, building maintenance and our obligations and responsibilities to students and community members. Board members were in agreement of moving forward with upcoming town presentations with the Proposed Budget Presentation for the 2019-2020 school year budget increase remaining at the current presentation and 1.77 percent increase. Ms. Sexton Read reviewed upcoming Budget Timeline Calendar of next meeting dates for Informal Town Presentations and Regular Board of Education meetings.
