EFFORTS TO REDUCE RACIAL, ETHNIC, AND ECONOMIC ISOLATION

Below is the description submitted by this school of how it provides educational opportunities for its students to interact with students and teachers from diverse racial, ethnic, and economic backgrounds.

Regional School District No. 7 represents the four communities of Barkhamsted, Colebrook, New Hartford and Norfolk where diversity is significantly limited. Our school district stretches over 160 square miles in northwestern Connecticut. All four of our towns qualify as rural areas, with the largest town population being 6,297. However, the school district consistently makes salient efforts to reduce racial, ethnic and economic isolation through the curriculum, special programs, and student activities. Our teachers are using technology to “open up the world” through the use of digital resources across all grade levels. Our students are actively involved with their sister school in Shandong, China. In April 2011, Northwestern High School students visited the school. Our students stayed in the homes of Chinese students and were completely immersed in Chinese culture. Students also visited Beijing and Xi’an, taking an excursion to the Great Wall of China. The district continues to make strides in increasing the number of students entering in the middle and high schools from neighboring towns. Our Agricultural Education program accepts students from Winchester and Torrington, towns with more diverse socioeconomic standing. This has resulted in an increased awareness of the differences and similarities of others. Student groups such as H.O.P.E. (Helping Others Promote Equality) celebrate the differences of humanity and work to promote tolerance and acceptance. Our students are actively involved in fundraising and a variety of community service activities that benefit the less fortunate. Northwestern junior and seniors travel to local elementary schools to volunteer their services for tutoring, training, coaching, recreation and garden clubs. Our high school banking students work with the elementary schools to teach them about the importance of saving money and other aspects of personal finance. The district provides regional opportunities for students in the areas of agricultural education, vocational education and special education programs. These programs greatly expand our diversity and ethnicity. Northwestern participates in a successful cooperative football program with The Gilbert School in Winsted. 31 Northwestern students currently play on the football team.

EQUITABLE ALLOCATION OF RESOURCES AMONG DISTRICT SCHOOLS

Below is the description submitted by this district of how it allocates resources to insure equity and address needs.

One of our Board of Education's goals is to provide adequate staffing to meet the needs of our students. The economic climate has caused administration to seek cost savings across the district and has challenged us to provide the best education possible through an equitable allocation of resources between schools. The education budget is initially prepared and submitted by each academic department to their principals. After careful review, the principals present the budget to the Business Manager and finally the Superintendent of Schools. The resources are carefully aligned with the needs of the middle school and high school. This year, the Board of Education was able to restore full time teaching positions to the middle school and add a part time science position to the high school. The middle school students are organized in teams. The students remain in these teams throughout 7th and 8th grade. Students loop with the same team of teachers for two years in middle school, increasing the ability of staff to monitor and support each student while building meaningful relationships. Financial equity has been established between the teams. The high school students are equally distributed between two Houses. Fiscal equity has been established.

SCHOOL DISTRICT IMPROVEMENT PLANS AND ACTIVITIES

The following narrative was submitted by this district.

Regional School District No. 7's administrators, teachers and support staff are dedicated to continuous improvement across all academic areas. One hour each week is devoted to working with student data to make informed decisions regarding teaching and learning. This time together allows teachers to discuss best-practice instructional strategies to ensure our students are afforded every opportunity to succeed. The district is also focused on assisting special education and academically challenged students in the Response to Intervention Program. Both special and regular education teachers provide high quality reading and math support through the RTI program. Support staff members have been reassigned to provide services for students with various academic and learning needs. A greater effort was made to infuse technology into the high school and special education curriculum. Extensive data is collected through monitoring processes and is used to make determinations for each student's personal Success Plan. The Student Success Plans are web-based which allows access to both teachers and parents. The plans are carefully tied to state standards associated with academic and personal progress, as well as school to career transition. Updated software programs have greatly improved the district's ability to communicate with parents. Our website allows for constant communication between the parents, community and the school. Our district offers many after school activities, clubs and sports programs for both the middle and high school.
